OF

ARTICLE I





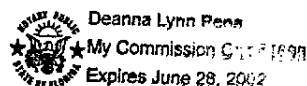
