PLAN OF MERGER

THIS PLAN OF MERGER (the Agreement") dated effective as of March 9, 2001 is by and between WEB CLASSIFIED, INC., a Florida corporation (the "Disappearing Corporation") and WEB CLASSIFIED INTERNATIONAL, INC., a Florida corporation (the "Surviving Corporation").

BACKGROUND
