I. NAME

The name of the corporation is SPARKLE CLEANING OF MARCO, INC.

II. TERM OF EXISTENCE

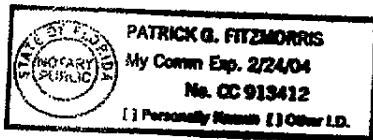




