The Corporation shall have a perpetual existence.

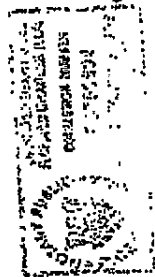
ARTICLE III - PURPOSE

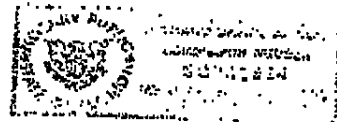
