ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The Power to adopt, amend, alter, or repeal these Articles of Incorporation as well as the By-laws of this corporation shall be reserved to the shareholders.

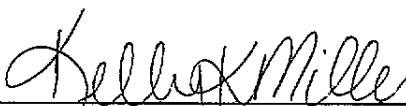
