

ARTICLES OF INCORPORATION OF
TEGOBI, INC.

1. Name. The name of the corporation is: TEGOBI, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value.
