**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
ALLEN & COMPANY FINANCIAL CORPORATION
a Florida Corporation**

Pursuant to the provisions of Florida Statutes Section 607.1006, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST:** The document number for this entity is P01000021967.
- SECOND:** Article V is amended to increase the total number of shares of common stock authorized for issuance from 2,000,000 to 16,500,000 shares. Article V is further amended to increase the total number of shares of stock authorized to be designated as "Class B Common Stock" from 500,000 to 15,000,000 shares.
- THIRD:** These Articles of Amendment will be effective on and as of the date filed with the Florida Secretary of State.
- FOURTH:** The forgoing amendment was approved by the shareholders. The number of votes cast for these amendments was sufficient for approval.
