**Article I - Name**

The name of the corporation is INSPECT FIRST, INC. (hereinafter referred to as the "Corporation").

**Article II - Adoption and Text of Amendments**

Article IV - Effective Date of Amendment


The effective date of these Articles of Amendment shall be the date of filing with the Florida Department of State.
