ARTICLES OF INCORPORATION OF DARNIC VENTURES INC



The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

<u>ARTICLE I – NAME</u>

The name of this corporation is DARNIC VENTURES INC.
