

ARTICLES OF INCORPORATION
OF
SOVERIGN MANAGEMENT, INC.

The undersigned incorporation hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I


ARTICLE X

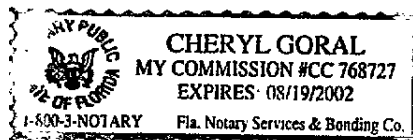


