WE THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLE I. NAME

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and Shareholders.


ARTICLE X, AMENDMENT

ARTICLE XI. SUB-CHAPTER S CORPORATION


This Corporation may be a Sub-Chapter S Corporation, as defined by the Internal Revenue Code.


