

ARTICLES OF INCORPORATION

Pursuant to Florida Statutes § 607 and § 621, the undersigned incorporator hereby submits these Articles of Incorporation for the purpose of forming a corporation (the "Corporation") under the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is HERITAGE RADIOLOGY OF WEST FLORIDA, P.A.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.
