"ARTICLE IV CAPITAL STOCK

The Corporation shall have the authority to issue 100,000,000 shares of common stock, par value \$.0001 per share."

Such amendment of the Articles of Incorporation of the Corporation has been duly approved, authorized and directed by the Board of Directors of the Corporation by Unanimous Written Consent of Board of Directors in Lieu of Special Meeting Thereof dated as of December 2, 2002 and by the shareholders of the Corporation by Written Consent of Shareholders dated as of December 2, 2002. The number of votes cast for the amendment was sufficient for approval. All other provisious of the Articles of Incorporation shall remain in full force and effect without any modification thereof.
