The undersigned, acting as the Incorporator of R.E.A.L. Parts of Florida, Inc. under Chapter 607 of the Florida Statutes, submits the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation is: R.E.A.L. Parts of Florida, Inc.

ARTICLE II DURATION AND COMMENCEMENT

The corporation will exist perpetually, commencing upon the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE III PURPOSE

The corporation is organized primarily for any lawful purpose, including, but not limited to the buying, selling and leasing of real estate, but shall also include the performance of activities related or incidental to the furtherance of the corporation's stated purpose and permitted under the laws of the United States and Florida.

ARTICLE IV PROHIBITED ACTIVITIES

The corporation shall not engage in any activities prohibited by Chapter 607 of the Florida Statutes, but shall otherwise have all powers granted by said Chapter.

ARTICLE V AUTHORIZED SHARES

The corporation is authorized to issue 100 shares of common stock. Shareholders of the corporation shall be limited as set forth in the Bylaws.

**ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is John A. Moyer, and the corporation's initial registered agent at that address is 603 S. Melville Avenue, Unit 19, Tampa, Florida 33606.

**ARTICLE VII
PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE VIII
DIRECTORS**

The initial Board of Directors of the corporation shall consist of one (1) member. The name and address of the corporation's initial director is:

The method of election of directors shall be as stated in the Bylaws.

**ARTICLE IX
INCORPORATOR**

**ARTICLE XI

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law.

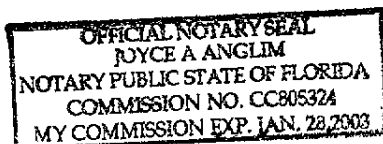

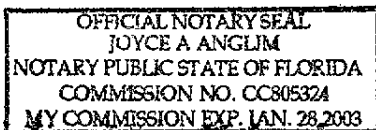
