ARTICLE XIII


Amendment



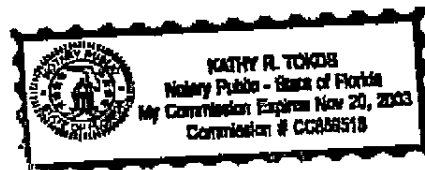
