# ARTICLES OF INCORPORATION

I, the undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, acting as incorporator of a corporation under the Florida Professional Service Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

# ARTICLE 1 - Name and Address

The name and address of this Corporation is:

# ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.

# ARTICLE III - Purpose

If a quorum is present, the affirmative vote of FIFTY-ONE PERCENT (51%) of shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

### ARTICLE XV - Management of Corporation by Directors

All corporate powers shall be exercised by or under the authority of, and the business affairs of this Corporation shall be managed under the direction of the Board of Directors of this Corporation.

# **ARTICLE XVI - Removal of Directors**

The shareholders of this Corporation shall not be entitled to remove any director from office without cause.

Dividends may be paid to shareholders only out of the unreserved and unrestricted earned surplus of the Corporation.
