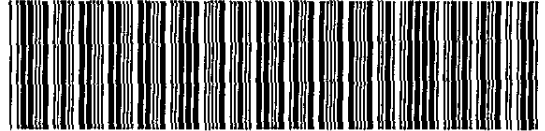

2. The name of the corporation after amendment:

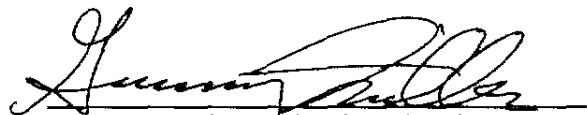
