The undersigned subscribers to these Articles of Incorporation competent to contract and for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt(s) the following Articles of incorporation.

The purpose(s) for which the Corporation is formed are as follows: To provide Public Relations for Corporation, Event Planning, Advertising, Promotion and Social Entertainment. To be performed herein as mentioned as fully and to the same extent as any natural persons might or could do, to engage in any and all legitimate purposes for which corporations may be organized under the General Corporation Laws of the State of Florida.

ARTICLE I. NAME

ARTICLE II. PRINCIPLE OFFICE

This Corporation reserves the right to amend, or repeal any prior provisions contained in these Articles of Incorporation or any amendment thereto.

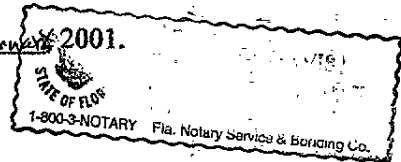
