Articles of Incorporation

of

ARTICLE I

NAME

The name of the Corporation is **Twelve Bravo Marketing, Inc.** The principal office address and the mailing address of said Corporation is 8787 Southside Boulevard #3816 Jacksonville, Florida 32256.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE

officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

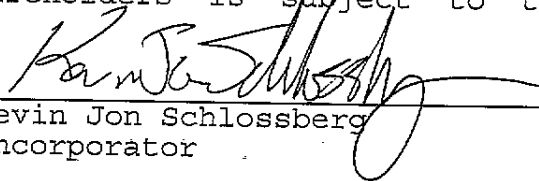

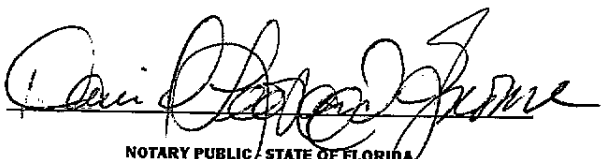

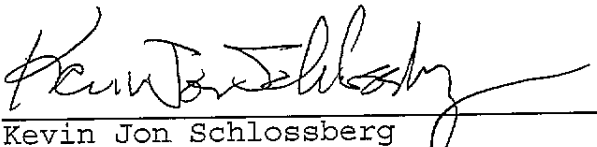
