
in the Board of Directors and the Shareholders.

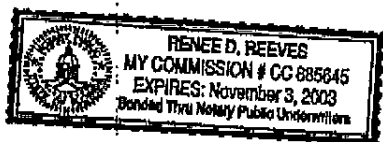


