ARTICLE I - NAME AND ADDRESS

The name of this corporation is **TCG-ENCLAVE, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 2937 S.W. 27th Avenue, Suite 303, Coconut Grove, Florida 33133.

ARTICLE II - PURPOSE

ARTICLE IX - INDEMNIFICATION


The Corporation shall indemnify any officer or director, or any former officer or director of the Corporation, to the fullest extent permitted by law.


