#### ARTICLES OF INCORPORATION

OF

#### COVE MARINE ASSOCIATES, INC.

I, the undersigned Incorporator and Subscriber, being a natural person competent to contract, hereby organize and incorporate under the laws of the State of Florida a corporation for profit as follows:

### ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be COVE MARINE ASSOCIATES, INC., having as its initial corporate mailing address: 1908 Tudor Road, Juno Beach, Florida 33408

#### **ARTICLE II - DURATION**

This corporation shall be perpetual in existence unless sooner dissolved according to law.

# **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business which corporations may transact pursuant to Chapter 607, Florida Statutes, including without limitation:

To conduct, engage in and carry on the general business of transportation by air, land and water in interstate, intrastate and foreign commerce of passengers, freight, articles of merchandise and cargo of every nature and description. To own, operate, lease, buy and manage transportation terminals and warehouses.

To represent municipalities, World Trade Centers and chambers in international trade before their potential users and investors.

To engage generally in ocean commerce in the carriage of goods by water upon the oceans, seas, and other waterways, to contract for, purchase, build, own, equip, furnish, sell, operate and charter to or from other persons, firms or corporations and operate steam, sail, or other boats, ships, vessels, tugs, barges, and lighters, or other property used in the transportation of freight; to engage in the transportation of passengers, and in the transportation, carriage, or storage of freight, mails, property, products, goods, and merchandise of every description.

To carry on the business of ship owners, builders, repairers, brokers, chandlers, agents, managers of shipping property, freight contractors, barge owners, vessel owners, lightermen, stevedoring, forwarding agents, factors, insurance brokers, warehouse persons or wharfingers.

To purchase, own, lease, operate, maintain, buy, sell, mortgage, and convey shipyards, wharves, plants, and manufacturers, for the building, equipping, remodeling, and repairing, of any and all kinds of ships, and vessels, of every class and description.

To engage in any lawful act or activity for which corporations may be formed under the business corporation law. The corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.

To own, operate, manage, acquire and deal in property, real and personal, which may be necessary to the conduct of the business. Without limiting any of the purposes or powers of the corporation it shall have the power to do any one or more or all of the things set forth, and all other things likely, directly or indirectly, to promote the interests of the Corporation. In the caring on of its business it shall have the power to do any and all things and powers which a corporation or natural person could do, either as a principal, agent, representative, lessor, lessee or otherwise, either alone or in conjunction with others, and in any part of the world. In addition, it shall have and exercise all rights, powers and privileges now belonging to or conferred upon corporations organized under Florida Statutes.

## ARTICLE IV - CAPITAL STOCK

The authorized capital stock of the corporation shall be One Hundred (100) shares common stock.

All of said stock shall be payable in cash, patents, stock, notes, accounts, claims, real estate or other property, or labor or services actually performed for the Corporation at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose. Property, labor or services may be purchased or paid for with the capital stock at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.
