The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

LAKEVIEW APARTMENTS OF SEBRING, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted is:

- To engage in every aspect and phase of the business of investing and reinvesting in real, tangible and intangible property.
- To manufacture, purchase, or otherwise acquire, and to own, mortgage, 2. pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services, of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, cooperative association, fraternal benefit society, state fair or exposition.

- To purchase the corporate assets of any other corporation and engage in the 5. same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
