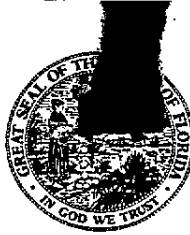

**AMENDMENT TO
ARTICLES OF INCORPORATION OF
CONCESSION MANAGEMENT GROUP, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, whose Articles of Incorporation were approved by and filed with the Secretary of State of Florida on March 7, 2001, document number P01000023724.

1. The following Amendment to the Articles of Incorporation was adopted by the Shareholders and the Directors of the Corporation on the 5th day of April, 2001, and the Shareholders and Directors of the Corporation have consented, authorized the following Amendment, in the manner prescribed by the Florida General Corporation Act.

A. Article VII of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE VII
Board of Directors**

The number of directors constituting the Board of Directors shall be one (1) and the name and address of the person who is to serve as the member thereof is as follows:

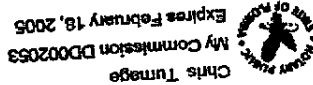
