

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be EQUITY ONE (FOREST VILLAGE PHASE II) INC.

ARTICLE II - CORPORATE ADDRESS



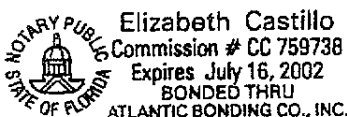


