**ARTICLE I**

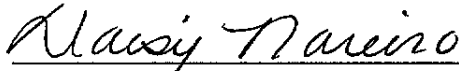

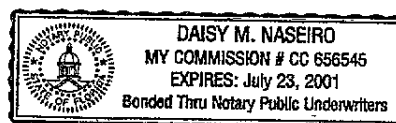
