After questioning my ex-partner, who is no longer involved with Creative Woodworking, I was able to resolve the problem. Please let me explain.


Creative Woodworking of Manatee, Inc. was formed in March 2001 with two partners involved, Bernard J. Lozon and myself, Rudy L. Rosa. Mr. Lozon's capacity was geared more toward the administrative end of the business and my expertise leans more toward the production end of the business. As of January 28, 2002, Mr. Lozon left the company and I remained as sole proprietor.

Since this transaction, I have had to pull together various loose ends administratively and this Annual Report/Uniform Business Report is one of many issues that I am finding was not given proper attention. Upon the resignation of Mr. Lozon I was not aware of this particular report that needed to be filed since this is my first experience being incorporated and pursuing a business venture on my own.

Considering that this is the first notice that I have physically received in my hands, I would like to request your consideration of waiving the reinstatement fee and accepting the \$150.00 UBR filing fee enclosed. In the future I will give this report top priority because I am a small company and cannot afford to let this happen again.
