# ARTICLES OF INCORPORATION

OF

RICHARD R. DWYER & COMPANY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE ONE:

The name of the Corporation is RICHARD R. DWYER & COMPANY, INC. ARTICLE TWO:

The duration of the corporation is perpetual with commencement at the time of filing these Articles.

### ARTICLE THREE:

The general purposes for which the corporation is organized are:
