

**ARTICLES OF INCORPORATION
OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Professional Corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this Corporation is **Law Offices of Peter Z. Kamenesh, P.A.**

**ARTICLE II
PURPOSE**

This Professional Corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

**ARTICLE III
CAPITAL STOCK**

This Corporation is authorized to issue 100 shares of \$10.00 par value common stock, which shall be designated as "Common Shares". All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof at a just valuation to be fixed by the Board of Directors.

**ARTICLE IV
VOTING RIGHTS**

Except as otherwise provided by law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.
