ARTICLES OF INCORPORATION

OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Professional Corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this Corporation is Law Offices of Peter Z. Kamenesh, P.A.
