# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ACP GLADES CORP.

Pursuant to Section 607.1005 of the Florida Business Corporation Act, the Articles of Incorporation of ACP GLADES CORP. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST:

The name of the Corporation is ACP GLADES CORP.

SECOND: Article 1 of the Articles of Incorporation is amended in its entirety to read as follows:

#### "ARTICLE I. NAME

The name of the Corporation is ACP GLADES MANAGER CORP."

THIRD: The foregoing amendment was adopted by the sole incorporator in accordance with Section 607.1005 of the Florida Statutes on March 29, 2001. No shareholder or board approval is required.
