## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FIRST NATIONAL V. C. GROUP COMPANY

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation, First National V. C. Group Company (P01000024412) adopts the following Articles of Amendment to its Articles of Incorporation.

### Article I. Amendment

The Articles of Incorporation of the Corporation are amended as follows:

Article V is deleted in its entirety and replaced with the following:

### Article V. Capital Stock

The Corporation shall have the authority to issue 100,000,000 shares of common stock, par value \$.001 per share. In addition, the Corporation shall have the authority to issue 15,525,000 shares of preferred stock, par value \$.0001 per share, which may be divided into series and with the preferences, limitations and relative rights determined by the Board of Directors.
