BY THESE ARTICLES OF INCORPORATION the incorporator <sup>form 1</sup> <sub>SECRETARY OF STATE  
TALLAHASSEE FLORIDA</sub> forms a corporation for profit under Florida law.

1. **NAME** The name of this Corporation is:


9. **BYLAWS**




