ARTICLES OF INCORPORATION OF HONEYCUTT REALTY, INC.

The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that they are also a director of such subsidiary or corporation.

ARTICLE IX - BYLAWS

The power to adopt, after, amend or repeal bylaws shall be vested in and is hereby reserved to the shareholders. Bylaws shall be adopted, aftered, amended or repealed as provided therein.
