We were not trying to evade paying the tax, but simply did not receive the information in time to make the payment. As soon as we became aware of the oversight, the payment was sent. Please try to help us out of this situation. Certainly, I hope the state of Florida does not want to drive us out of business. Everyone makes mistakes, and we have been frustrated trying to resolve this matter trying to find someone in Tallassee with a little compassion. Hopefully a just compromise can be reached, and a fair adjustment can be made.
