The name of this corporation is DESTINY ENTERPRISES, INC., Document Number **P01000024629.**

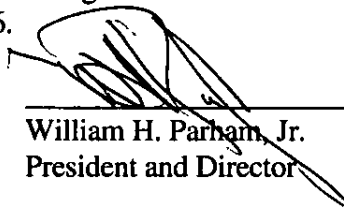
ARTICLE II

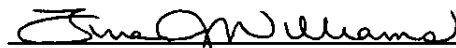
