

ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME.

The name of the Corporation is KIDS PROPERTY INVESTMENTS, INC.

ARTICLE II. DURATION.

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE.
