ARTICLES OF INCORPORATION

OF

The undersigned hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional association (the "Corporation") for profit in accordance with the laws of the State of Florida (2)

ARTICLE I Name

The name of this corporation shall be:

ARTICLE II Existence of Corporation

This corporation shall begin existence on the date of filing of these Articles with the Secretary of State, Department of Corporations for the State of Florida and shall have perpetual existence.

ARTICLE III Purposes

The corporation may engage in the practice of medicine and the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV General Powers

The corporation shall have power:

- To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- To lend money for its corporate purposes, invest and reinvest its funds, and to take (g) and hold real and personal property as security for the payment of funds so loaned or invested.
- To conduct its business, carry on its operations, and have offices and exercise the (h) power granted by this act within or without this state.
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
- To make and alter bylaws, not inconsistent with its Articles of Incorporation or with the laws of the State of Florida, for the administration and regulation of the affairs of the corporation.
- To make donations for the public welfare or for charitable, scientific or educational (k) purposes.
- To transact any lawful business which the Board of Directors shall find will be in aid **(I)** of governmental policy.
