

#### ARTICLE I - NAME

The name of this corporation is GEORGE R. LUCK, M.D., P.A., and the mailing address shall be 650 Glades Road, Boca Raton, FL 33431.

### **ARTICLE II - DURATION**

This Corporation is to exist perpetually.

### ARTICLE III - PURPOSE

The general nature of the business to be transacted by this Corporation is to engage . in the practice of medicine, and any and all business or other lawful activity permitted under the laws of the State of Florida.

# ARTICLE IV - CAPITAL STOCK
