ARTICLES OF INCORPORATION OF CCS JACKSONVILLE MAIL SERVICES CORP.

The undersigned, for the purpose of forming a corporation under the Florida Business

Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is CCS Jacksonville Mail Services Corp.

ARTICLE TWO PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1031 Parkridge Circle East, Jacksonville, Florida 32211.

ARTICLE THREE CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 1. To engage in the business of offering packaging, shipping, mailing, communications and information products and services to residential and commercial customers.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in

3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE FIVE CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is one hundred (100). Such shares shall be of a single class, and shall have a par value of one dollar (\$1.00) per share.
