The undersigned incorporator, being a natural person of the age of twenty one or more, desiring to form a corporation under the laws of the State of Florida, does hereby certify as follows:

ARTICLE I

Name

The name of the corporation shall be GL, INC.

ARTICLE II

Principal Place of Business and

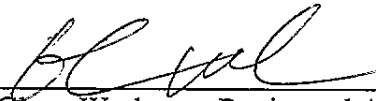
