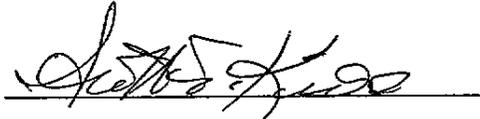
**ARTICLE VIII-INDEMNIFICATION**

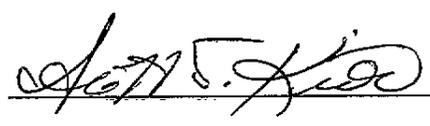
