ARTICLES OF INCORPORATION

OF

MICHAEL DIAZ, JR., P.A.

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I. Name of Corporation

The name of this Corporation shall be MICHAEL DIAZ, JR., P.A.

ARTICLE II. Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation are as follows:

- (a) The general nature of the business to be transacted by this Corporation shall be the practice of law. In addition, this Corporation may carry on any business and have and exercise all of the powers conferred by the laws of the State of Florida except as such may be limited by the provisions of the Florida Professional Service Corporation Act as in effect from time to time. 
