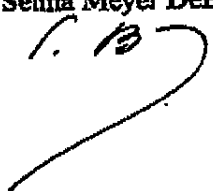
#### **ARTICLE FIVE REGISTERED OFFICE, AGENT AND PRINCIPAL PLACE OF BUSINESS**

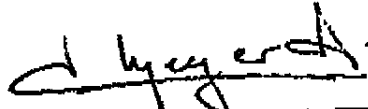
