ARTICLE I - NAME

The name of the corporation **MAXMAR INTERNATIONAL, INC., 800 NORTH MIAMI AVENUE, SUITE 1003, MIAMI, FL 33136.**

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE


