

The name of this corporation is SIESTA MORTGAGE, INC.

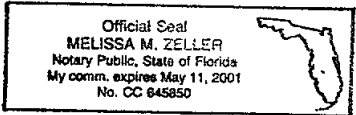

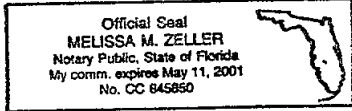
