The undersigned incorporator, for the purpose of forming a corporation, under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation ("corporation") shall be **RISSI CHERIE DECORATING, INC.**

ARTICLE II - EFFECTIVE DATE

The existence of the corporation shall begin on 1 March 2001.

ARTICLE III - PRINCIPAL OFFICER


