ARTICLE I

NAME

The name of this professional service corporation shall be JOLENE ARMSTRONG, P.A., hereinafter referred to as the corporation.

ARTICLE II

DURATION

The corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Florida Department of State.

ARTICLE III

PURPOSE

The corporation is organized pursuant to Chapter 621, Florida Statutes (2000), for the purpose of rendering professional real estate services consistent with the laws of the State of Florida.



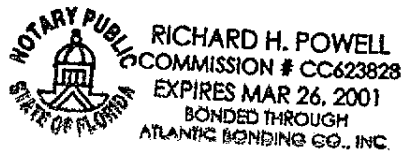


