WE, THE UNDERSIGNED HEREBY ASSOCIATE OURSELVES SECRETARY OF STATE TOGETHER FOR THE PURPOSE OF BECOMING A CORPORATION LAHASSEE, FLORIDA UNDER THE LAWS OF THE STATE OF FLORIDA PROVIDING FOR THE FORMATION, LIABILITY, RIGHTS, PRIVILEGES AND IMMUNITIES OF CORPORATION FOR PROFIT.
