ARTICLES OF INCORPORATION

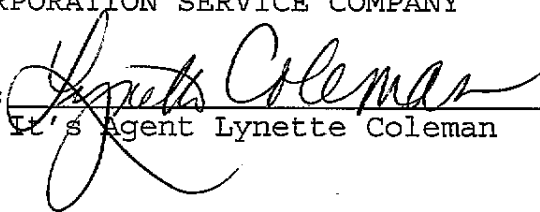

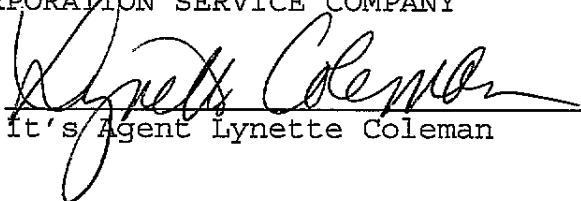
